The council offered other potential sites to the veterans for their memorial: 1) at the high school 2) the cemetery 3) Ward Cove point. Paul Dawson proposed an alternative site, the old sewer plant site on Main St. After much discussion it was decided that the veterans have three sites to look at and decide which site they would like to consider for their memorial.
