Press Release: 003, COVID-19 Harbor Quarantine Policy

For Immediate Release

Based on State Health Mandate 10.1, travelers from out of state are required to quarantine for a period of 14 days. The City of Craig has instituted a policy to monitor and enforce quarantines of vessels arriving in the Craig Harbors from outside of the State of Alaska.

All vessels entering the Craig Harbors, or docking/mooring at any city owned harbor facility will be screened by the City of Craig. If the vessel, or any crew member or passenger on the vessel has traveled from outside of the State of Alaska within the past 14 days, then the vessel and crew are subject to the quarantine.

All vessels docking at Craig harbor facilities are required to contact the Craig Harbor Office at 907-826-3404 (or on VHF Channel 16) or, if the harbor staff is not available, contact the Craig Dispatch Center at 907-826-3330. No crew members or passengers may get off of vessels that have traveled from outside of the state, or who have crew members or passengers who have traveled from out of state until all screening has been completed. Failure to follow screening requirements may subject crew members or passengers to trespass orders, citations, or arrest and may result in the vessel being ordered to leave the Craig Harbor facilities and being banned from facilities for 14 days.

Vessels that have left the Craig harbors within the past seven day (and who have not traveled outside of the state or taken on crew members or passengers that have left the state within the past 14 days) are exempt from this policy. Vessels who have permanent moorage or assigned transient moorage in Craig Harbors (and who have not traveled outside of the state or taken on crew members or passengers that have left the state within the past 14 days) are also exempt from the policy.

Vessels who have traveled from outside of the state or have crew members or passengers who have traveled from outside of the state within the past 14 days are subject to all quarantine requirements listed in State Health Mandate 10.1 and must

submit a travel declaration to the State of Alaska. Everyone on the vessel must also submit a copy of the travel declaration or their name, home address, quarantine address, and date of arrival to the Craig Harbormaster or Craig Dispatch Center.
