To: Craig City CouncilFrom: Brian Templin, City AdministratorDate: January 27, 2023RE: Boat Launch Maintenance/Modifications

In 2022 the council had some discussion regarding the condition and grade of the boat launch at False Island. The council asked staff to look at the cost and feasibility of primarily removing the lip at the top of the ramp and reducing the grade at that point to between 9% and 10%.

In addition to these goals, staff determined that some work to repair scouring and to replace a stacked rock wall north of the float bulkhead needed some work as well.

Recently we got two bids for the work:

- B-3 Contractors, \$39,860
- CBC Construction, \$40,550

Both bids appear to cover the base work and B-3's bid includes the rock wall work as well. Both firms are capable of performing the work in a quality manner.

I am waiting for a call back from ADF&G to ensure that we stay within any funding requirements of the original construction grant (the launch was constructed in 1999 using ADF&G funds). It is likely that we will also have to secure a US Army Corps of Engineer's permit for any in water work (rock wall and scouring).

This item was not included in the FY23 budget. If the council is inclined to do the work before the upcoming season it will need to appropriate funds and direct staff to proceed.

Recommended Motion: Move to direct staff to appropriate \$40,000 from the Capital Reserve Fund and proceed with permitting and construction work to upgrade the existing boat launch.

As per your request B-3 Contractors proposes to provide all required Labor, Materials, Equipment, and supervision necessary to complete the scope of work described below. This scope as presented and the attached drawing represents our understanding of the changes desired and the construction procedures needed to complete.

Scope of work;


1. Demo and remove the existing cement slab approximately 67 ft. long and 16 ft. wide, located up slope from the concrete planks. The demoed cement and rebar to be loaded into trucks and hauled off site to a location provided by city of Craig.

This assumes the cement slab is 8" thick and has one layer of rebar.

- 2. Excavate the subgrade under the slab area as needed to create the 10% slope. Provide, place, and compact gravel fill as needed to make the new sloped subgrade. Excavated material to be hauled off site to location provided by Craig.
- 3. Set concrete forms as needed to make the new slab. Place rebar as per the details in proposed drawing. #4 bar at 18" each way. Pour new cement slab 10" thick. Concrete to be minimum of 6 sack, 4000 psi mix.
- 4. Backfill along the outside edge of the new slab area with excavated material. This assumes the material is acceptable quality. Sort the material and place to keep the larger rocks 8" to 12" at the surface to minimize erosion.
- 5. Coordinate the work schedule with the tides cycles as needed to maximize the work time between tides. Estimated 7 work days.
