HEARING FROM THE PUBLIC

Final Reading and Public Hearing for Ordinance 648, Additions to Craig Endowment Fund Investment Policies Chapter 3.15.050 (A)(9) and Chapter 3.15.055 (B)(3)

Renee Rue came and spoke on behalf of Mountain View Cab, and her brother, owner Albert Owen. Renee is the main driver for the business, and had an agreement with Jeff Music when he sold her the business. Renee expressed concern about the lack of business on the island, and what another cab company might mean for Mountain View Cab. Presented to the Council by Renee was a signed petition with sixty signatures on it, as well as a letter from a patron of Mountain View Cab opposing the application from Jeff Music. Mayor Watson conveyed that the Council does not tell businesses they cannot operate in Craig because there are other businesses in the same industry. Joni added that competition only makes a business better. Chief Ely mentioned that there have been random stops and insurance checks by his staff, all of which were satisfactory.

REPORTS FROM CITY OFFICIALS

Mayor- Mayor Watson reported the Capital Budget is looking grim for Craig after visiting Juneau. Greg asked about the new Representative Kreiss-Tomkins, and Mayor Watson was impressed with how attentive the Representative was. Mayor Watson also commented that the lack of funding is putting a damper on Southeast Alaska. The timing of his trip to Ketchikan for IFA business was beneficial as he was able to be present at the borough assembly meeting there to comment on the borough study of Prince of Wales and the discussion on whether or not to annex the Island. Mayor Watson was able to bring up reasons why this annexation would be detrimental to Prince of Wales.

Administrator- Jon added to his staff report that there is a budget workshop with the school district if any council would like to attend.

Treasurer- The assessors were here this week, and there were more sales than usual this year. The server is in, and will be installed next week.

Aquatic Manager- Nicole provided a written report.

City Clerk- Kassi provided a written report.

City Planner- Absent excused.

EMS Coordinator- Chaundell provided a written report.

Harbormaster- Absent excused.

Police Chief- RJ provided a written report. Joni commented on the litter on the side of the road that indicates an increase in "huffing" around Craig. RJ has been in contact with the AC manager and they have been working together to secure the products in the store that can be abused by kids.

Public Works-Ron attended the SDS conference in Juneau last week. Scrap metal barge was here last week, and will be back again. Train 4 and Train 1 are complete with rebuild, and Train 2 and Train 3 will be started next week.

Parks and Rec-Absent excused.

Library-Amy provided a written report. The OWL project has been cut for funding. The Chamber of Commerce's raffle is split among the libraries, and Amy would like to begin a new account for the expansion of the library including the portion of the raffle as well as income from book sales.

Jon clarified the process for disposal of city property. The Council makes the final decision on the method of disposal. Jim asked about the services. Jon explained the process for instillation of services. Jim See expressed the need for residential housing in Craig. Staff is working toward this goal. MOTION CARRIED.

UNFINISHED BUSINESS

Draft letter regarding the Tongass National Forest Plan Five-year Review- Jon would like additional time to prepare the draft as the comment deadline has been extended. The letter will be based on the POWCAC letter drafted last month.

Sealaska Lands Bill Discussion- Mayor Watson expressed concern for all the loggers that are working off island and away from family. Joni mentioned that the high school population is down to 78, and it could be due to the decline of the timber industry. Joni's main concern is having jobs that will keep people on the island. Jim See doesn't agree with the land that Sealaska has closed. Mike is concerned that this is an opportunity for Sealaska to get the prime timber without addressing the City's concerns. Mike is also concerned about the old village sites, sacred sites, and economic sites. The Bill is limiting the land that residents are able to subsistence harvest. Mike commented that this is a large impact on everyone. Mike mentioned that they were told the Sealaska bill would stand on its own or not at all, but now it seems it will be written on to another bill. Mike would support the bill after a few alterations. Mayor Watson will draft a letter addressing the larger bill and then the pre-selection, and the reasons why the Council cannot support it and have the Council approve it.

Tanner Crab Court Extension/ Salmonberry Subdivision utilities bid solicitation

Jon explained that the need for housing in Craig, and the need for additional funding to install these utilities. The bids will come back to the Council prior to making a selection. Staff will put this item to bid. MOTION CARRIED

Continuation of stipend pay for volunteer medics

moved to authorize staff to continue paying the EMT's on a per call basis on a rate established by the City Council from January to June 2013.

The Council authorized stipend pay for medics until December of 2012 and Chaundell would like to extend it through the fiscal year. Joyce would like to add that EMT's are not contractors, and if pay exceeded \$600 they will need a 1099. The safer course would be to set the EMT's up as part time employees. Jon and Joyce will be revising the employee job classifications, in which case they could write in the on-call EMT's under their own classification.

Mayor Watson mentioned the 19,500 dollars for the show Communities of Distinction to come and spend time in Craig. The Council was opposed to appropriating funds for this purpose.

Cannery Property Boardwalk Maintenance

motions to authorize staff to restart work on the cannery point park project using donated funds and the City general funds based upon subsequent council appropriation.

Jon would like some direction on whether or not the council would like to see the Cannery boardwalk redone, or taken out and replaced with a gravel pathway. The Council agreed that the cost to replace the boardwalk was not proportionate to the use of the boardwalk. Joni requested to have a public hearing for the residents to have a chance to comment on the decision. Mayor Watson would like to wait until we have couple more meetings with public comment to begin this project.

ECONOMY & MARKETS

Mixed market returns in February

The S&P 500 gained +1.4% last month and is up +6.5% year to date. It and many of the other U.S. indices are flirting with all-time highs. However, the overseas markets have struggled. The EAFE index of stocks in developed countries was off -1% while emerging market equities saw a -1.3% decline in February.

Fourth quarter corporate earnings have been impressive with S&P 500 company profits up +8% year over year. And the takeover game is beginning to heat up – consider Heinz and Dell for example.

Bonds continued their range bound ways in February with the 10 year Treasury trading at just under 2%. The total return for the Barclays Aggregate bond index was +0.5% last month, but it is down -0.2% year to date.

Gold has sold off over \$100 this year bringing the precious metal to only \$1,565 an ounce. Commodities, per the Dow Jones-UBS Commodities Index, are down about -8% over the past twelve months.

The U.S. economy has hit a bit of a soft patch recently probably owing to the payroll tax hike and higher gasoline prices (up 48 cents a gallon year to date). The first revision of 2012 fourth-quarter GDP growth showed that the economy rose +0.1%, versus the -0.1% originally reported. That still leaves 2012 growth around +2%, one half the average seen in previous cycles. The Bloomberg consensus forecast for economic growth this year is a tepid +1.8%.

The Federal Reserve shocked the markets when it released minutes showing considerable worry about the exit strategy for its QE bond buying program. It may be that they begin to "taper off" the \$85 billion of monthly purchases late this summer. But it remains quite likely that they will keep short term rates close to zero through 2014. All of this may mean a bear steepening of the yield curve as the year marches on.

The sequester kicked in as expected and may weigh on the U.S. markets. It's \$85 billion of cuts or just over 2% of the budget. Since Federal spending has doubled in 10 years, it's hard to get too excited about a 2% cut. Our fiscal soap opera continues, but the sky is not falling.

In testimony before congress Fed Chairman Bernanke said "a substantial portion of the recent progress in lowering the deficit has been concentrated in nearterm budget changes, which...could create a headwind for the economic recovery." That's true and most analysts would prefer a backend loaded deal that comes to grips with our long run budget and entitlement problems. It looks like that ain't gonna happen anytime soon.

It's Baaack...

The inconclusive nature of the Italian elections brought the euro crisis back front and center again. Comedian Beppe Grillio's Five Star party got 26% of the vote and former Prime Minister Silvio Berlusconi, received 30%. The adult in the room, Bersani, is trying to form a minority government, but that would be inherently unstable. I am shocked, shocked, I tell you. Italy: unstable and chaotic? Say it ain't so.

Italy has Europe's third largest economy, has contracted for six quarters in a row, and is sporting an unemployment rate of 11.2%. It has seen its unit labor costs go way up relative to Germany and so it isn't competitive (many in the periphery of Europe aren't). While its deficit is low, the country has a high debt burden of 120% of GDP. Like many in Europe the Italians are tired of austerity. Let's blame someone – I know, the Germans!

It is going to be a long road back for Europe, full of twists and turns. The ECB has helped by easing financial conditions and taken "tail risk" off the table, for now. We remain skeptical, but acknowledge that equity valuations are cheap across the pond.



■ Fixed income performed positively across sectors. The 10-year U.S. Treasury yield fell by 10 basis points (bps) in February. The drop was driven mainly by a decrease in the real yield, although inflation expectations declined slightly as well.

■ Fed Chairman Ben Bernanke made clear in his testimony to the Senate that the Fed remains highly accommodative. He acknowledged that there may be

some "frothiness" in certain assets classes, but the Fed considers the benefits of further quantitative easing to outweigh the costs of balance sheet expansion. We continue to expect current bond buying policy to remain in place into the fourth quarter.

■ Agency and MBS performance remained highly correlated to Treasuries, as spreads stayed in a narrow range. Fannie and Freddie announced they will form a joint venture for securitizing home loans, starting steps to combining the two entities.

■ Longer-term technicals continue to point to a continued shortage of high quality credits. Corporates and ABS produced a positive +0.77% and +0.31%, respectively. We continue to think high quality corporates and ABS spreads have room to tighten in the year ahead.

■ New issue Commercial Mortgage Backed Securities continue to outpace issuance from 2012. Current and anticipated supply weighed on higher quality tranches as spreads widened. However, subordinated legacy bonds remain in demand.

■ Municipal prices were essentially unchanged in February. Due to wide quality spreads, the A and BBB credits continue to outperform the high grades. YTD returns from the A/BBB sectors have been double those from the AAA/AA sectors. Municipals continue to have headline risk as Detroit may be run by the State of Michigan and Illinois presented a 2014 budget that reflects the fiscal troubles of underfunded pensions.

■ The S&P 500 rose by just over +1% in February. The market pulled back from earlier gains on hawkish FOMC minutes. Equities remain more attractive than bonds. The S&P 500 dividend yield is greater than nominal Treasury yields.

Developed international markets lost -1.0% as uncertainty around Italian politics caused various European equity markets to fall. The Italian equity markets lost -8.7% on a very inconclusive election. The standout performer across the globe was Japan's Topix up nearly +4.0%. This was driven by a further decline in the value of the yen against the dollar, amid expectations that the Bank of Japan will loosen monetary policy even further.

■ Equities in emerging markets did not fare as well overall as those in developed markets in dollar terms, ending the month down -1.3%. Capital Economics notes: stock markets in emerging Europe (down nearly -5% on average) generally underperformed, while those in Asia ex Japan fared less badly (down around -1%). Emerging markets look attractively valued relative to developed markets. Relative valuation is trading at 7.1% discount to history.

■ International treasuries lost -2.2% on a stronger dollar and concerns over European politics. Moody's downgraded the UK's credit rating one notch to Aa1, with a stable outlook.

■ After a positive start in January, commodity prices fell back in February, leaving the asset class in slightly negative territory year to date. Gold is off -5% year to date and oil is roughly unchanged.

RE: Resolution 13-07: Request from Seafood Producers Cooperative for Two-Year Access Permit to use City Dock

Attached you will find Resolution 13-07. The resolution authorizes staff to issue a City of Craig access permit to Seafood Producers Cooperative to use the City Dock from the end of June to the beginning of September in 2013 and 2014.

As the council is aware, Seafood Producers Cooperative (SPC), based in Sitka, has operated a fish buying station at the City Dock for the past three summers. In each of the past three years, SPC occupied the dock under the terms of an access permit. Section 16.04.020 of the Craig Municipal Code authorizes staff to issue access permits without city council approval for non-destructive uses of city property, the duration of which is less than one year. However, the city council may issue an access permit for a period of up to two years if the council adopts a resolution authorizing issue of the permit.

SPC officials contacted me recently to ask if the organization can secure use of the City Dock for more than one year at a time. I explained that an access permit cannot be issued administratively for a period greater than one year, but that the city council may authorize a two-year use. I told SPC staff that if the company wanted more than one year's access to the City Dock, it would have to request a two-year access permit, or apply for a lease of the property. The company chose to request a two year access permit. The attached letter from SPC summarizes their proposed use of the dock.

A copy of the access permit issued to SPC in 2012 is attached. If the council approves Resolution 13-07, staff would likely write an access permit very similar to the one issued each of the past three years to SPC. As the company states in the attached letter, it would like city permission to install a hoist on the dock. City staff will work with SPC to determine if installation of a second hoist is practical at the dock, its proposed location, terms of use, and so on.

In my conversations with the Craig Harbormaster, SPC's use of the City Dock over the past three years, between the end of June and the first week of September, has not created a hardship or difficulty on the downtown waterfront. SPC is prompt with its utility, ice, and permit fee payments to the city for activities at the dock.

Recommendation

Approve Resolution 13-07.

First of all, I would like to thank Mr. Jon Boling, the Craig Harbor Master and the City of Craig Council, for supporting Seafood Producers Cooperative's salmon buying operation over the past 3 seasons. Our relationship with the City of Craig has been fundamental to successfully servicing our 35 resident members, as well as other cooperative owners who move into the area throughout the fishing season. Being able to provide fishermen the opportunity to deliver at a central location with established shore side support services continues to be our long term goal.

SPC would like to request a 2 year easement access for the City dock. A longer term lease will provide additional stability to achieve our business plan. In essence, we would like to move towards establishing a more permanent shore side unloading operation. The concept would be to develop additional support infrastructure, including residential employee staff and housing.

We do not anticipate a need for more area at this time. We would set up our operation around June 25th and vacate the dock around September 3-6th. This is consistent with our previous agreements. We have discussed the installation of a second hoist on the public dock which we are prepared to move forward on with your approval. The installation would be professionally engineered and certified prior to use. SPC will cover all costs. The intent would be to leave the hoist intact over the off season and be available for use at the City's discretion.

CITY OF CRAIG ACCESS PERMIT

The City of Craig (hereafter "city"), through authority granted to it under 16.04.020 of the Craig Municipal Code, hereby grants an access permit to Seafood Producers Coop, whose address is 507 Katlian St., Sitka, AK 99835, (hereafter "permittee") for the use of a portion of the City Dock and adjacent tidelands of the Tidelands Addition to USS 1430 (hereafter "the property") for use as an area to receive and transport seafood, to park vessels, vehicles and equipment directly related to the transportation of seafood received at the property, subject to the following conditions:

1. <u>Permit Purpose</u>. That this permit is valid for the use of the property for purchasing, offloading, prepping and shipping seafood and for parking vessels, vehicles and equipment directly related to the transportation of seafood received at the property. No other use may be made of the property without prior approval from the city.

2. <u>Site Contamination Prohibited; Environmental Compliance Required</u>. (a) Any violation, at the site of the property, by permittee, or by a third party present upon the land with permittee's permission, of an environmental statute or regulation of the city, state or federal governments shall be grounds for immediate termination of the permit by the city, at the city's sole discretion. By entering into the permit, the permittee agrees not to make any claim for monetary damages against the city for permit cancellation pursuant to this subsection.

(b) The permittee shall at all times manage permittee's activities upon the property, and the activities of third parties present with permittee's permission, so as to positively prevent any and all contamination of the property which would violate any statute or regulation, which could subject the city to enforcement action by a state or federal agency, or which could subject the city to statutory or common law liability, diminish the value of the land, or cause city expenditures for response costs caused by a hazardous substances release.

(c) By entering into the permit, the permittee agrees to defend and indemnify the city from and against any and all claims by third parties (including governmental entities and industry pollution-based claims) brought against city by reason of activities on the property during the effective period of the permit.

(d) By entering into the permit, the permittee agrees to reimburse the city for any and all expenses reasonably incurred by the city (including any response or site cleanup costs) because of activities on the property during the effective period of the permit.

3. <u>Site Cleanup.</u> Permittee agrees that she is individually responsible for removing all waste products and other items placed by them, or resulting from their activities, from the property. Removal will be completed no later than sixty days after the expiration of

this permit, or 60 days of notice by the city that the permit is being terminated as described in item 4 below. All fixtures and equipment of whatsoever nature, that permittee shall have installed upon the property, whether permanently affixed or otherwise, shall continue to be the property of the permittee and may be removed by them at the expiration or termination of this permit or of any renewal thereof; and at their own expense, permittee shall repair any injury to the property resulting from such removal. Such disposal must be done in compliance with State of Alaska and local regulations, and as directed by city staff. Failure to do so will subject permittee to expenses incurred by City as disclosed in item 2(d) above.

4. <u>Permit Termination</u>. Permittee agrees that the city reserves the right to terminate this permit for any reason. If the city exercises this option the permittee will be notified by certified mail sent to the address above, or by hand service of the notice to terminate the permit. The permit will be terminated 30 days from the receipt of the letter, date of the hand service, or the date the letter is returned to the city if delivery is not accepted by the permittee. This permit will also be terminated if permittee violates or fails to maintain any condition of this permit; or if payment is not made as prescribed in section 9 of this permit.

5. <u>Hold Harmless.</u> Permittee agrees to hold harmless, indemnify and defend City against any and all claims for damage, injury, or wrongful death which may be brought or asserted by Permittee, its agents, or third parties resulting from Permittee's use or occupancy of the property.

6. <u>Site Maintenance.</u> Permittee agrees to maintain the permittee's use area and storage area in clean and good condition. This includes removal of waste products resulting from carving, unused raw materials and any other waste generated by permittee's activities on the property during the effective period of the permit.

7. <u>Non-Exclusive Use of Site.</u> Permittee acknowledges that the City Dock is used by the general public for access to a public ramp and float at the dock. Permittee agrees to maintain public vehicle and foot access to the ramp and float at all times. City reserves the right to use the remainder of the property or allow third party use of the remainder of the property.

Permittee agrees to make the public use crane on the property available to the general public at such times as permittee's activities allow for public access to the dock face.

8. <u>Access, Parking and Interference.</u> Permittee will access the property, park vehicles and conduct activities in a manner which shall not interfere with clear access to the remainder of the property by the city, leaseholders, permit holders or other parties authorized by the city.

9. <u>Utilities.</u> Services provided under this permit do not include utility services. Permittee must secure at its own cost any utility service it needs at the property, including but not limited to water and electric utilities. Permittee agrees to transfer existing electric meter accounts at the property to its name for the duration of the permit.

10. <u>Payment and Effective Period</u>. In consideration for this permit, permittee agrees to pay to the city \$6,076.50 for the period June 25, 2012 to September 10, 2012 and \$275.00 per week thereafter, based on the schedule of values below.



Please note the attached agreement from Carson Dorn, Inc., the firm we have used in the past years to handle the hazardous waste for our community Clean Up Week. The Agreement and fee structure are similar to years past and the funding is included in the current Budget.

The proposed date for the Household Hazardous Waste Materials collection is Saturday, May 11th 2013. This would make Monday May 6th through Saturday May 11th, the City Clean Up Week.

RECOMMENDATION

To approve the Agreement for the collection and handling of the materials gathered during the City Clean Up Week.

AGREEMENT

This AGREEMENT, dated this 1st day of March, 2013, is between the City of Craig hereinafter called City and Carson Dorn, Inc., hereinafter called CDI.

It is mutually agreed as follows:

I. SERVICE BY CDI

- A. CDI shall collect and dispose of household hazardous waste materials collected on May 11, 2013 at the Klawock Landfill.
- B. CDI shall exercise authority on the management of the material collected.
- C. CDI shall provide drums and cartons to contain the material collected, labels, appropriate shipping papers, and shall provide for transportation, recycling, reclaiming, and/or disposal of materials. All drums and cartons shall be clearly marked as containing household waste only and labeled as Non Regulated.
- D. CDI shall provide up to two persons trained in the acceptance, sorting, packing, and shipping of collected materials.
- E. CDI shall make every reasonable effort to remove all collected material from the site by June 11, 2013.
- F. The EPA identification number for management of materials under conditions of this agreement is AKD983075953 CDI shall report actual drum volumes collected to the designated community contact at noon and the end of the event. The volumes will be compared to the projected number of drums budgeted for in the agreement. CDI shall submit a detailed report and invoice to DEC and the City including:
 - Copies of all manifests
 - Description and quantity of each type of material disposed of by drum and DOT classification
 - The mode of disposal
 - The mode of transportation.
- G. CDI shall invoice the City \$3,250 for mobilization, operations, and management for up to a six drum, one carton event. Shipping of the waste collected at the event will be approximately \$1,725. Collection of any drums and cartons over this limit will require approval by the City's representative listed below. Disposal of the waste collected will be invoiced to the City at \$380 per drum and \$760 per cubic yard carton. If the amount of liable drums and cartons collected in 2013 exceeds the estimated level, the City shall pay for the additional amount of services required to dispose of such additional waste. All invoices and reports should be directed to:

- H. CDI certifies that it uses:
 - 1. Valid Environmental Protection Agency identification numbers for the transportation, treatment, storage, and disposal of hazardous waste.
 - 2. Liability insurance in effect for claims arising out of death or bodily injury and property damage from hazardous waste transport, treatment, storage, and disposal, including vehicle liability and legal defense costs in the amount of \$1,000,000 as evidenced by a certificate of insurance for General, Automobile, and Environmental Liability Coverage.
- I. CDI warrants that it understands the currently known hazards and suspected hazards that are presented to persons, property, and the environment by the transport, treatment, and disposal of hazardous waste. CDI warrants that it will perform all services under this contract in a safe, efficient, and lawful manner using industry-accepted practices and in full compliance with all applicable state and federal laws and regulations.
- J. CDI shall be liable for and indemnity from and against any injury or loss whatsoever resulting from the negligent act or omission of any employee or agent of CDI, or from failure or inadequacy of any equipment of CDI. CDI is not barred from pursuing any legal action against any employee or agent of CDI, or any owner, manufacturer, or designer of equipment, who causes such property or personal injury or loss as described in this subparagraph IJ
- K. CDI is and shall perform this agreement as an independent contractor, and as such, shall have and maintain complete control over all its employees and operations. Neither CDI, nor anyone employed by it, shall represent, act, purport to act, or to be deemed to be the agent, representative, or employee of the City or of any of the other participating municipalities or agencies.
- L. CDI shall comply with all applicable regulations of the United States Department of Transportation and the Resource Conservation and Recovery Act in transporting the waste collected at this event.
- M. In the event of a spill or other accidental discharge of hazardous material at the collection site, CDI will promptly notify the ADEC and the local fire department.

II. RESPONSIBILITIES OF THE CITY

- A. City shall provide areas for the collection of household generated hazardous waste from 9:00 AM until 4:00 PM the day of the event.
- B. The City shall provide personnel to assist in sorting and packing collected material, and shall provide a secure site in the event that waste must be stored for later shipment.
- C. The City shall, within 30 days of receipt of the invoice and satisfactory documentation from CDI, pay the base contract amount. If additional amounts are invoiced, the City shall negotiate arrangements for payment of the remainder within 60 days of date of invoice.

- D. The City shall notify appropriate emergency services of the Collection Day event and shall provide traffic control.
- E. The City shall be liable and indemnify from and against any injury or loss whatsoever resulting from the negligent act or omission of any employee or agent of the City, or from failure or inadequacy of any equipment of the City. The City is not barred from pursuing any legal action against any employee or agent of the City, or any owner, manufacturer, or designer of equipment, who causes such property or personal injury or loss as described in this subparagraph IIE.
- F. The City shall coordinate publicity and activities for the Household Hazardous Waste Collection Day (hereinafter "Collection Day")
- The City shall coordinate the provision of personnel, equipment, and services requested, G. including equipment mobilized to the site as air freight, tables, protection against inclement weather, plastic sheeting, absorbent material, and protective clothing, and shall provide any requested assistance in operational planning.
- H. The City shall produce a flyer on behalf of the Collection Day which shall contain:
 - A location at which the Collection Day shall operate and the time of operation.
 - A telephone number that residents may call for detailed information.
 - Instructions on what to bring to the Collection Day and on items that should not be brought.
 - The City shall arrange for the distribution of the flyers.
- I. The City shall provide Personnel on the Collection Day to assist in operations at the Collection Site. The City shall designate a person to sign the Non-hazardous Shipping Manifest or authorize CDI to sign on the City's behalf.

III. COUNSEL

Parties to this agreement have the right to seek independent counsel to review this A. agreement, and have exercised that right if so desired.

IV. MODIFICATION

No change, alterations, modifications, or addition to this contract will be effective unless it is A. in writing and properly signed by the parties hereto.

RE: Consider Authorization of Elecrical Work at Port St. Nicholas Hatchery Facility

POW Hatchery Association staff has apparently found that some of the wiring in the king salmon hatchery building adjacent to the city's water treatment plant at Port St. Nicholas is in need of repair. Hatchery staff solicited a review of the wiring from two electricians and developed a list of wiring work needed at the facility.

Estimates to complete the work have ranged from a few thousand dollars to more than \$9,000. I have worked with Daniel Goodness at the POW Hatchery Association to prioritize the list of needed work. That list is attached. Also attached is an e-mail string summarizing the work.

POWHA would like the city to pay the cost of the electrical tasks related to the hatchery building. POWHA plans other electrical work at the site, but has plans to pay for that work itself. The city still holds several thousand dollars from the old king salmon derby program before the hatchery assumed management of the derby. If the council approves use of city funds for the electrical work, staff would draw the funds from the king salmon account.

At this point I have authorized Thomas and Sons Electric LLC to begin work on the facility, so long as the cost does not exceed \$3,000. A council motion is needed to authorize the completion of the entire list of items on the list prepared by the electrician.

Recommendation

That the city council authorize the appropriation of the funds necessary to complete electrical work at the king salmon hatchery building at Port St. Nicholas.

Hi, Jon, and thanks for your reply. I will do my best to prioritize the list. I have to agree, what Don told me is that he estimates the project may cost less, as long as he doesn't run into unforeseen problems.

I have compared Sam's list with the one Don made, and Don's Item #7 is one thing that Sam didn't mention. That's because adding the 30 amp circuit at the rear of the building is something I asked Don to do, to provide power for the trailer. This happened after Sam did his inspection last fall.

1) What I see as the highest priority involves the high voltage "appliances" in the Mechanical Room, the two transformers. Getting them off the floor, and tied into the breaker panel properly, seems like the first thing to do.

2) Installing ground wires in all conduits where there are no ground wires, but where 3 prong receptacles exist....this seems like the next high priority.

3) At this point, perhaps balancing the phases (I don't know what this involves...) is very important.

4) Perhaps Don's Item #4 (Remove improper boxes and covers and replace with weatherproof type) is next?

I would think that at this point, anything else that the electrician deems necessary, for the facility to comply with code, would naturally follow. Performing Items 1-4 would allow staff to use extension cords safely, and turn lighting on and off safely.

The last thing I'd like for Don to do is wire in the trailer, which POWHA can pay for separately. So, how does that look? Would you say that Don can start on the high priority items soon?

PS The fry will need to be ponded within about two weeks. At that point, there must be full time employee(s) working on the site, 7 days a week. I continue to hesitate to hire anyone for the full-time position until the facility is deemed safe by the electricians.

I compared the list of tasks in the attachment from Don Thomas to the list below that you got received from Sam Peters, to try to match up the two. It looks like Don has covered items 1, 3, 5, 6, and 7 from Sam's list, but it's not clear to me that Don's list covers all the items that Sam brought up. It could be that Don's items capture all of Sam's, but again, I can't tell.

Sam's off-the-cuff estimate of about \$2,500 to complete the projects is much less than Don's \$9,650 estimate. Don did tell me that his estimate could be quite high if the labor portion does not take him as long as he thinks it might. Given this uncertainty, perhaps we should prioritize what we need done, and have Don work on the higher priority items first. Can you prioritize the list of tasks so we can have Don start on the most important items?
