FIRST SUPPLEMENTAL BUDGET FOR F/Y 2000-2001

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRAIG:

Section 1. <u>Classification</u>. This ordinance is a non-code ordinance and is not of a general and permanent nature and shall not become a part of the code of the City of Craiq, Alaska.

Section 2. <u>Effective Date.</u> This ordinance shall become effective immediately upon adoption.

Section 3. <u>Authorization and Appropriation</u>. The appropriations attached hereto are adopted and authorized for the period of July 1,2000 through June 30, 2001 and are the budget for that period. The Administrator may modify line item expenditures within an authorized appropriation to another line item any amount which would not annually exceed ten (10) percent or \$10,000, whichever is more.
