ORDINANCE NO. 572

AMENDING THE CRAIG MUNICIPAL CODE, CHAPTER 10.04, ENFORCEMENT AND OBEDIENCE AND CHAPTER 10.06, PROVISIONS OF STATE LAW
ADOPTED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CRAIG:

Section 1. Classification. This ordinance is of a general and permanent nature and the code sections adopted shall become a part of the code of the City of Craig, Alaska.

Section 2. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

Section 3. Effective Date. This ordinance shall become effective immediately upon adoption.

Section 4. Action. This ordinance amends Title 10, Vehicles and Traffic, Chapter 10.04 and 10.06, by deleting those words shown with strikethrough text (~~strikethrough~~) and by adding those words that are underlined and bolded.

Sections:

10.04.40 Applicability to bicycles, push carts or animals.

10.04.040 Applicability to **Bicycles**, push carts or animals.

Every person propelling any push cart, riding an animal upon a roadway, riding a bicycle, and every person driving any animal-drawn vehicle shall be subject to the provisions of this title applicable to the driver of any vehicle, except those provisions of this title which by their very nature can have no application.
