

NOTES:

The Point of Beginning being identified on this plat as Cor. No. 1, Lot 2-A and the point for Cor. No. 5, Lot 2-A are identical with the angle points for lines 15-16 and 11-12 respectively as shown on as shown on the official BLM plat for U.S. Survey 3857. Also, the line between these points was computed using the meander information as shown on the same official plat.

The afore mentioned points would be located in the field by using proper BLM 1947 Manual of Survey Instruction Procedures.

This is a paper plat, compiled by the Division of Lands from official BLM plat and field notes of U.S. Survey No. 3857, as surveyed by BLM in 1961.

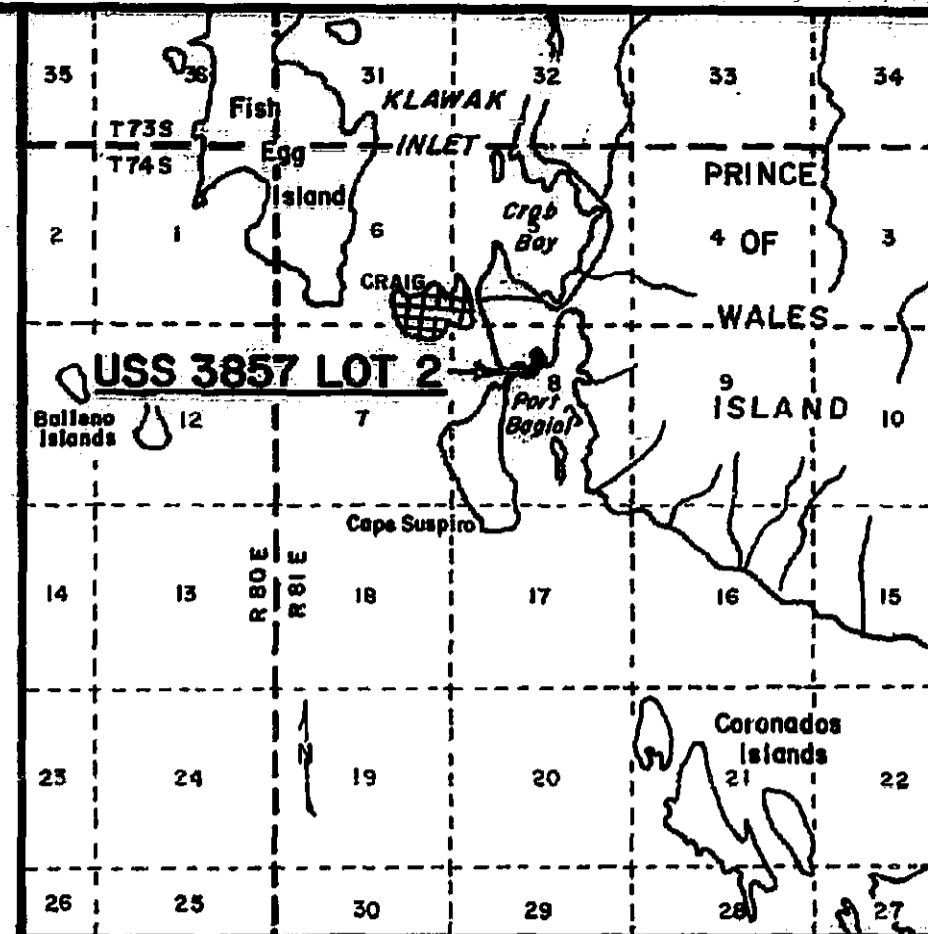
