# **Position Summary**

The Mechanic/Automated Collection Truck Operator is under the supervision of the Public Works Director. The Mechanic/Automated Collection Truck Operator shall have knowledge of, and perform, routine and advanced mechanical duties on the City of Craig's fleet and facility equipment. The Mechanic/Automated Collection Truck Operator will also operate and maintain the City of Craig solid waste collection truck. The City of Craig Public Works is a small team requiring cross training and support of other team members.

## **Duties and Responsibilities**

- Perform basic mechanical work on City of Craig vehicles and equipment including repairs, maintenance, fabrication and conditioning of City of Craig equipment.
- Create and maintain documentation and files on all vehicles and equipment.
- Operate the City of Craig solid waste collection equipment.
- Receive and apply training and education to maintain and repair the solid waste collection equipment and the City of Craig fleet as needed.
- Maintain the Public Works facilities at 202 Cold Storage Road in a professional manner.
- Participate on Public Works crews and task assignments relating to repair and maintenance of City of Craig facilities, as well as new installations.
- Operate and maintain City of Craig equipment and property in a proper and customary manner, and as required by governing agencies.
- Participate in safety and the education of safety as it applies to the Public Works
   Department and the City of Craig.
- Promote safety in the workplace as well as the city.
- Perform duties with quality and efficiency with regard to instruction, specifications, and timeliness.
